## William Beckett: From Linnaean Hill to the Library of Congress

On Saturday, April 20, visitors came to Rock Creek Park to learn more about the remarkable life of William Beckett, who was once the enslaved manager of Joshua Peirce's nursery business on Linnaean Hill, now park headquarters. The event was the culmination of a year-long research project that began with the discovery of compelling new evidence that Joshua Peirce was not just Beckett's enslaver — he may also have been his father.

With support from HumanitiesDC, the Friends worked with the National Park Service and Howard University PhD candidate Antonio Austin to research Beckett's life before and after emancipation. Together, we created a temporary exhibit that traced Beckett's long and distinguished career as a DC business owner, church leader, presidential coachman, and doorkeeper at the Library of Congress.

William Beckett: From Linnaean Hill to the Library of Congress was on view near Klingle Mansion from April 20 to May 5, 2024. The exhibit opening featured a conversation about Beckett's life with Project Historian Antonio Austin, Rock Creek Park Acting Superintendent Brian Joyner, and Howard University Professor of History Dr. Elizabeth Clark-Lewis.

#### **Remembering Quentin Looney**



Quentin Looney, former Board President of the Friends of Peirce Mill and long-time mill volunteer, passed away on September 28, 2023, after a long struggle with Alzheimer's Disease.

Quentin came to Peirce Mill after a distinguished career as a chemist and expert in renewable energy. He held a PhD in chemistry from the University of Pittsburgh and brought a scientist's curiosity and a lifelong interest in food and history — to his volunteer work at the mill. Quentin organized the

first cider tasting at Peirce Mill, and started the mill's popular ice cream-making demonstration. A graduate of Penn State's famous Ice Cream Short Course, he enjoyed talking about the chemistry and history of ice cream. Quentin also loved showing park visitors Peirce Mill's wooden machinery. As Board President from 2014–17, Quentin led efforts to restore the mill's barrel hoist, and helped bring chef Alice Waters to Peirce Mill for a visit in 2012.

We'll remember Quentin's gentle kindness and unstoppable curiosity, and will miss spending time with him at Peirce Mill, talking about waterpower and ice cream.

#### Meet the New Miller, Aaron Grigsby

With support from the National Park Foundation, the Friends of Peirce Mill recently hired a part-time miller, Aaron Grigsby. He'll be working with the National Park Service and volunteers to operate the mill one weekend a month this summer. See front page for milling demonstration dates.

When Aaron isn't running Washington's last working gristmill, he's one of the millers at Deep Roots Milling in Virginia's



Blue Ridge Mountains. They grind and sell locally grown grain at historic Woodson's Mill, a wooden gristmill built in the 1790s.

Aaron visited Peirce Mill last fall, when Deep Roots Milling participated in the first Mid-Atlantic Grain Fair. We're looking forward to working with Aaron during the 2024 milling season. He'll be milling with us through October, when Peirce Mill will host its second Grain Fair!

We're also bringing back a summer favorite: our annual **Ice Cream-Making Demonstration** returns on Saturday, August 10, from 11:00 am to 12:00 pm. Watch how ice cream was made back when Peirce Mill was built, using cream, sugar, vanilla, and plenty of elbow grease.

We'll celebrate the end of summer — and the start of a new school year — with **Children's Day** on Saturday, September 14, from 10:00 am to 2:00 pm. We'll have special tours of the mill for kids and plenty of hands-on crafts and activities. And this year, we'll be joined by Teatro La Bolsa.
